



## Official Rules

### Prize:

**Grand Prize:** One (1) winning business/association/organization will receive four (4) tickets to the Happy Together 2018 concert, two (2) tickets to five (5) more shows of your choice\*, EPC Lobby Box advertising for your business for 2018-19 EPC season, two (2) reserved parking passes for chosen shows, Donor Lounge access for chosen shows, two (2) drink coupons for chosen shows. \*Must be part of the 2018-19 EPC season of events (rental shows excluded)

**Eligibility:** No purchase necessary to enter or win. The Share the Love Contest is only open to US residents of IL, IN, MO & KY, 18 years of age or older. Current employees and volunteers of the Effingham Performance Center and/or Patton Printing, members of the immediate families (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) or persons living in the same household (whether or not related) of all the foregoing are not eligible to enter or win. - 3.) Entries deemed inappropriate will be removed from the contest and disqualified for the Share the Love Contest. Participants agree and acknowledge by sending their contest entry to the Patton Printing Facebook page, Patton Printing/EPC may choose to use entry posts in future marketing material and grant application process with no further compensation to the participant.
- 4.) One (1) winner will be randomly selected on Tuesday, July 31<sup>st</sup> from all eligible entries received from the Patton Printing Facebook page. The winner will be notified by email or private message on Facebook. Odds of winning will depend on the number of eligible entries received.

The winner must appear in person at the Effingham Performance Center box office during regular business hours no later than Wednesday, August 8<sup>th</sup> at 5:00pm (the "Prize Claim Date"), to complete all required waivers and releases before the prize will be awarded. Any objection to or failure to sign the required releases will result in forfeiture of the prize. No prize will be mailed under any circumstances.

The prize includes only the specifically enumerated items listed in the "prize" section above. The winner is solely responsible for the payment of all federal, state and local taxes with respect to their prize.

**General Rules:**
